NOTE: (E-filed returns must include the W2 form AND confirmation page and are acceptable only if dated within the last 12 months.) What are CDL holders required to do? CDL holders required to have a "certified" medical status who fail to provide and keep up-to-date their medical examiner's certificate with TDOSHS will become "not-certified" and they may lose their CDL privileges.
